

This product is small in size large in power, and it adopts the current relatively advanced truthless motor demon mode.

It has under voltage, over current and over temperature protection.

- Undervoltage protection means that the battery is not charged in time or when the battery voltage drops to a certain degree, the machine will not start.
- Overcurrent protection is an overload protection, overload of using the machine will lead to the current rise high when it reaches to a certain extent, it will automatically protect to prevent burning the motor.
- Overtemperature protection long time using of the machine wit make the electronic components hot, the controller will issue instructions for protection. The machine will return to normal after the electronic components cool down.
- Power on protection function. in the case of switch locked, the machine will not start when connect the battery The machine can only be started after restart. which can effectively prevent the unexpected situation

OPERATIONS

1.ALWAYS maintain a minimum safety zone of 45 feet (15 meters) from where you are working

Don't allow others to enter the safety zone unless you have shut the tea harvester Off, and the blades have completely stopped moving also pay attention to the animals around you

- 2. Plug the dc tea plucking machine cable into the battery socket
- 3 Turn on/off switch turn on the switch button on the handle, the tea plucking machine starts working, turn off the switch button, and the machine will be turned off.


Before staling the machine. please check if at accessories used have been entailed properly before the start of the operation. It is determined that the blade does not touch any object, such as brandies, stones, etc. If any problems, please turn off the switch immediately and pull the cable plug.

When operating, be careful not to touch lubricant, resin, grease, to ensure a stable and balanced footing.

MATTERS NEEDING ATTENTION

- 1. The blades must be kept sharp at all times to achieve good work efficacy. The gap between the cutter and blade should not be too large. but it should not be too small It is difficult to cut leaves on if it has too large clearance If with too small gap. the machine does not work.*
- Only use the machine when the tight is sufficient and the vision is clear Please pay attention to whether the ground is wet and slippery, and if there is ice (there is danger slipping down). You must have a safe foothold do not stand in a semi sold unstable place to work and pay attention to balance at all times.
- Keep all parts of the body away from the cutting blade Do not remove cutting materials (leaves) or hold them while the blade is moving. Make sure the switch is off when removing the clog Mouse may result in serious or fatal ',runes
